INSTRUTIONS

- A shareholder desiring to exercise vote by Postal Ballot may complete this postal ballot form and send it to the Scrutinizer in enclosed postage pre-paid self- addressed envelop. Postage will be borne and paid by the Company. Envelopes containing postal ballot, if sent by courier at the expense of shareholder will also be accepted.
- 2. This form should be completed and signed by the shareholder (as per the specimen signature registered with the Company/Depository Participants. In case of joint holding, this Form should be completed and signed by first named shareholder and in his /her absence, by next named joint holder.
- 3. In case shares held by the companies, trusts, societies, etc. the duly completed postal ballot form should be accompanied by a certified true copy of Board Resolution/Authority. Where the form has been signed by a representative of President of India or of the Governor of a State, a certified copy of the nomination should be accompany the postal ballot form.
- 4. The consent must be accorded by recording the assent in the Column 'FOR' and dissent in the Column 'AGAINST' by placing a tick mark (\checkmark) in appropriate column.
- 5. Unsigned Postal Ballot Form will be rejected.
- 6. A shareholder need not use all the votes nor needs to cast all votes in same way.
- 7. Duly completed postal ballot form should reach the Scrutinizer not later than the close of 5 P.M. on 24th September, 2015. All postal ballot form received after this date will be treated as if reply from such shareholder has not been received.
- 8. A shareholder may request for duplicate postal ballot form, if so required. However, duly filled duplicate postal ballot form should reach the Scrutinizer not later than the date specified at item no. 7 above.
- 9. Shareholders are requested not to send any other paper along with postal ballot form in enclosed postage prepaid self addressed form.
- 10. The Company is also offering e-voting facility as an alternate, for all its members to enable them to cast their votes electronically instead of using the Postal Ballot Form. The detailed procedure of e-voting has been enumerated in notes to postal ballot Notice dated 30th May, 2015.
- 11. Voting rights shall be reckoned on the paid up value of shares registered in name of the shareholders as on 14th August, 2015.
- 12. The Scrutinizer's decision on the validity of the postal ballot form shall be final.
- 13. The results of postal ballot will be declared in manner as specified in the Notice.
