न्यूयार्क, २० अगस्त (भाषा)।

डोनाल्ड ट्रंप पर कटाक्ष करते हुए पूर्व अमेरिकी राष्ट्रपति बराक ओबामा ने अपने उत्तराधिकारी पर राष्ट्रपति पद को एक 'रियेलिटी शो' की तरह देखने का आरोप लगाया और कहा कि शीर्ष रिपब्लिकन नेता 'इस पर अच्छा नहीं कर पाए क्योंकि वह कर ही नहीं सकते हैं।'

देश के पहले अश्वेत राष्ट्रपति ओबामा बुधवार को डेमोक्रेटिक राष्ट्रीय सम्मेलन (डीएनसी) की तीसरी रात्रि में डिजिटल संबोधन दे रहे थे। ओबामा ने कहा कि बाइडन और हैरिस के पास चीजों को करने के लिए आवश्य अनुभव व ठोस नीतियां हैं।

रूस के विपक्षी नेता एलेक्सी नवलनी विमान यात्रा के दौरान कथित रूप से जहर दिए जाने के बाद कोमा में चले गए हैं और उन्हें साइबेरिया में अस्पताल के गहन चिकित्सा कक्ष में वेंटिलेटर पर रखा गया है। नवलनी के सहयोगियों का मानना है कि राजनीतिक गतिविधियों की वजह से उन्हें जहर दिया गया

उनकी प्रवक्ता किरा यारमीश ने ट्वीट कर बताया कि राष्ट्रपति व्लादिमीर पुतिन के धुर विरोधी 44 वर्षीय नवलनी जब साइबेरिया के शहर तोमस्क से हवाई जहाज से मास्को लौट रहे थे तब वह बीमार पड़ गए। उन्होंने कहा, 'ओमस्क में विमान की आपात लैंडिंग कराई गई, नवलनी को जहर दिया गया है।' यारमीश ने 'इको मास्कोवी रेडियो स्टेशन' को बताया कि उन्होंने गुरुवार को विमान में सवार होने से पहले हवाई अड्डे पर स्थित कैफे से चाय पी थी जिसमें कुछ दिया गया होगा। उन्होंने बताया कि नवलनी को पसीना आ रहा था और उन्होंने मुझसे बात करने को कहा ताकि वह आवाज पर ध्यान केंद्रित कर सके। इसके बाद वह शौचालय गए जहां

वह बेहोश हो गए। वह कोमा में है और उनकी हालत गंभीर है। अन्य विपक्षी हस्तियों ने इस मामले में क्रेमलिन (रूसी राष्ट्रपति का कार्यालय) का हाथ होने की आशंका जताई है। रूसी प्रदर्शन समूह पुस्सी रॉयट के सदस्य प्योत्र र्विजलोव ने कहा, 'हम आश्वस्त है कि नवलनी या मुझको निशाना बनाने की क्षमता रूस के राजनीतिक नेतृत्व के आदेश पर केवल रूसी सुरक्षा सेवा के लोगों के पास है।' विंजलोव ख़ुद भी 2018 में संदिग्ध रूप से जहर दिए जाने के बाद मरते-मरते बचे थे। उन्होंने कहा, 'हमारा मानना है कि निश्चित तौर पर पुतिन ने व्यक्तिगत तौर
